#### **VOTING WITHOUT ATTENDING THE ANNUAL GENERAL MEETING**

A Member who is entitled to vote at the Meeting and who does not wish to attend and vote at the Meeting personally may vote by appointing a proxy or attorney to attend and vote on their behalf at the Meeting.

#### **APPOINTING A PROXY**

A Member who is entitled to vote at the Meeting has a right to appoint a proxy to attend and vote on their behalf. The proxy may, but need not, be a Member. A Proxy Form is enclosed with this Notice of Meeting.

A proxy's authority to speak and vote for a Member at the Meeting is suspended if the Member (or his or her

Attorney) is present at the

Meeting.

In accordance with the Constitution, if a proxy appointment is signed by the Member but does not name the proxy or proxies in whose favour it is given, the Chairperson may either exercise the proxy or complete the appointment by inserting the name or names of one or more Directors or the Secretary.

To be effective, the Proxy Form (and, if it is signed by an Attorney, the original or a certified copy of the relevant Power of Attorney) must be received **no later than 10.00am (Brisbane time) on Thursday, 11 November 2021** by the Returning Officer at the address or email shown below (and on the top of Proxy Form).

#### Items 5 and 6. Annual Reports and Financial Statements and Reports

RSPCA QLD's Annual Impact Report for 2021 and the financial report (which includes the financial statements and Directors' declaration) and Auditor's report for the financial year ended 30 June 2021 will be tabled at the AGM. No vote is required for these items of business under the Constitution or the Corporations Act.

Members will be given a reasonable opportunity at the Meeting to ask questions and make comments on these reports, and on the business and operations of RSPCA QLD.

#### Item 7. Election of Directors

#### 7.1 Vacancies and candidates

Under the Constitution the permitted maximum number of Directors is nine (9).

The Constitution specifies how directors are to be elected and hold office. The Constitution includes provisions which provide for retirement of directors by rotation. Under these provisions, at each AGM, half of the directors are required to retire and, being eligible, may stand for re-election

Upon his passing in January 2021, the directorship held by Michael Bowers became vacant. RSPCA QLD would like to acknowledge his service and contribution to the organisation and offer its condolences to his family.

Consequently, there are now five (5) vacancies to be filled with director (re-)elections at the Meeting.

On 24 September 2021, RSPCA QLD called for nominations for the election of Directors at the Meeting. Five (5) Nominations were received by the Close of Nominations; all directors retiring in according with the requirements of the Constitution are standing for re-election. Accordingly, there are five (5) candidates in total.

## **7.2** Voting for Directors

The Chairperson will call a poll on each of the five (5) resolutions for the election of a Director set out in item 7 of the Notice in accordance with clause 5.3 of the Constitution.

Voting Members are entitled to vote FOR or AGAINST or ABSTAIN from voting in respect of each of the candidates. A vote will be invalid if more than one option is selected for the same candidate.

In order to be elected, a candidate must receive more votes validly cast in favour of the Resolution for their election than against. Abstentions will not be included in calculating the requisite majority.
